Transportation Secretary Sean Duffy Announces Availability of \$5.4 Billion in Bridge Funding to Get America Building Again

The U.S. Department of Transportation’s Federal Highway Administration (FHWA) today announced nearly \$4.9 billion in available funding for major bridge projects through the Bridge Investment Program, and up to \$500 million for repairing or replacing bridges in rural areas through the Competitive Highway Bridge Program. The funding opportunity removes requirements that tied critical infrastructure funding to social justice and climate initiatives.



The announcement of \$5.4 billion in bridge funding represents a major opportunity for public works and road & bridge departments across the country. For local agencies, this funding can help address aging infrastructure, accelerate repair and replacement projects, and enhance safety for the traveling public. It also means greater potential for job creation, improved transportation efficiency, and long-term economic benefits for communities that rely on strong, reliable infrastructure. Departments should begin preparing shovel-ready projects and identifying priority needs to take full advantage of this federal investment.

Public Works Disaster/Hurricane Preparedness - Can Your Department Do More?

Disaster preparedness is essential for public works professionals, who play a critical role in protecting infrastructure and ensuring community resilience

during emergencies. From restoring roads and utilities to coordinating debris removal and supporting emergency response teams, public works personnel are often among the first to respond and the last to leave.

Proper planning and training equip them to act quickly and effectively, minimizing downtime, reducing damage, and safeguarding public safety. By proactively preparing for natural disasters, severe weather, and other crises, public works teams help maintain continuity of essential services and strengthen a community's ability to recover and rebuild.

The resources below can help equip your department with the tools, guidance, and coordination needed to build a stronger, more prepared public works response - before, during, and after hurricane events. Lastly, consider working with [Texas Division of Emergency Management](#) when planning responses and evacuations.



***This hurricane season, Texas coastal communities will receive evacuation notices 60 hours before a hurricane's expected landfall—extended from the usual 48-hour timeline. This temporary change is due to an extensive construction project along Interstate 45, the region's primary evacuation route.**

For public works departments, this earlier notice means more time to prepare critical infrastructure, stage traffic control equipment, and assist with emergency response coordination. It also increases the urgency to adjust work schedules, mobilize crews, and secure job sites ahead of evacuations. While not a permanent policy shift, this proactive measure highlights the need for public works teams to stay flexible and ready to support community safety under evolving conditions.

U.S. Transportation Secretary Sean P. Duffy Announces Over \$1.5

Billion to Repair Roads and Bridges Damaged by Natural Disasters, Including Hurricane Helene

U.S. Transportation Secretary Sean P. Duffy has announced over \$1.5 billion in federal Emergency Relief (ER) funding to help repair transportation infrastructure damaged by natural disasters, with a significant portion—more than \$683 million—allocated to address damage from Hurricane Helene. The funds, administered by the Federal Highway Administration (FHWA), will support emergency repair work in 36 states, the District of Columbia, Puerto Rico, Guam, and the U.S. Virgin Islands. This includes repairs to federal-aid highways and federally owned roads affected by hurricanes, wildfires, floods, and other extreme weather events.



Secretary Duffy emphasized the administration's commitment to removing barriers and accelerating repairs, citing the example of North Carolina's I-40 repairs, projected to save two-thirds of cost and time.

What This Means for Texas Public Works:

While Texas is not directly listed in this round of allocations, this federal support sets a clear precedent for swift disaster relief funding following major events. For Texas public works professionals, it underscores the importance of:

- Disaster preparedness and documentation—to ensure eligibility for FHWA Emergency Relief funds.
- Pre-positioned recovery plans and assessments, especially as hurricane season intensifies.
- Timely coordination with state and federal agencies to initiate repair efforts and secure funding.
- Remaining informed on evolving funding opportunities and federal response timelines that could impact local infrastructure recovery efforts after future disasters.

Texas public works departments should review their emergency response protocols and infrastructure vulnerabilities now to position themselves for potential funding and assistance in the event of a disaster.




